

**SUMMARY OF EXECUTIVE ORDERS FOR DIESEL, LPG, AND CNG/LNG ENGINE CERTIFICATION DATA  
MHD/HDO FOR CLASS 6 (GVWR 19,501 - 26,000 LBS) AND CLASS 7 (GVWR 26,001 - 33,000 LBS) TRUCKS  
(updated September 2, 2014)**

A summary of engines **not eligible** for funding under the Proposition 1B Program Guidelines is provided in this Table. The list has been created from the Executive Orders published on the Air Resources Board (ARB) website (<http://www.arb.ca.gov/html/eo.htm> and select number series A). This Table will allow various entities participating in the Program to view a list of engines that are **not eligible** for projects funded by this Program. Though staff will work to update the Table to provide the most current information, it is the responsibility of the applicant to ensure that the truck uses a certified engine (from the most current Executive Order on ARB's website). Any questions related to the engine eligibility may be directed to the appropriate trade corridor liaison for the Proposition 1B Program at ARB.

**Class 7 trucks are required to be equipped with a MY2010 or newer engine.**

**Class 6 trucks are required to be equipped with a new MY2013+ engine.**
