

2014 ANNUAL ENFORCEMENT REPORT SUMMARY

Highlighted achievements -- Air Resources Board's Enforcement Program in 2014

- ❖ **Enforced nearly 70 different regulatory programs**
- ❖ **Closed 3,208 enforcement actions to bring violators into compliance, assessing \$17,165,891 in penalties**
- ❖ **Over \$2 million of penalties from 153 case settlements supported three supplemental environmental project categories, to help fund cleaner school buses and community college classes on how to repair dirty diesel engines and small gasoline engines**

Program Highlights

Heavy-Duty Diesel Field Inspections and Citations: Conducted 29,608 inspections, closed 2,082 citations, and collected \$1,683,200 in penalties

Conducted 10,949 inspections and issued 842 citations in or near disadvantaged communities and the Mexican border; participated in diesel regulation awareness media events; trained local diesel regulation enforcement partners in field inspections

Heavy-Duty Diesel Investigations: Closed 870 cases for \$3,471,712

Major cases: SK Innovation Co., LTD, \$790,000, verified diesel emission control strategies; Vallejo Citizens Transit Company, \$387,750, urban bus; County of Los Angeles DPW, \$256,375 and JR Custom Harvesting, Inc., \$140,925, various diesel risk reduction regulations

Marine Investigations: Closed 41 cases for \$990,827

Major cases: total of \$673,758 from five cargo handling equipment companies, including \$390,733 from Progress Rail; total of \$312,969 from 26 international shipping companies for burning high sulfur fuel within 24 nautical miles of California's shoreline

Vehicle Investigations: Closed 44 cases for \$624,500

Major case: Enterprise Rent-A-Car, \$560,000 for offering to rent non-California certified vehicles

Engine and Parts Investigations: Closed 38 cases for \$5,642,027

Major cases: H & S Performance LLC, \$1,000,000, on-road aftermarket parts; Motor Science Enterprise, Inc., \$722,000, laboratory and certification fraud; Doosan, \$647,500, compression-ignition engines; MTD Southwest Inc., \$435,000, small off-road engines; Yoshimura Research, \$90,000, off-road aftermarket parts

Fuels Investigations: Closed 16 cases for \$1,599,700

Major cases: Tesoro Refining and Marketing Company, \$1,014,000; Chevron USA Inc., \$329,700; and VITOL, Inc., \$70,000; all for various violations of the California Reformulated Gasoline Regulation

Consumer Products Investigations: Closed 79 cases for \$2,178,625

Major cases: FleetPride, Inc., \$418,500, window washer fluid; Apothecary Products, Inc., \$400,000 and Carl Zeiss Vision, Inc., \$240,000, glass cleaner; Redken L'Oreal USA, \$146,500, hair styling products; Envion LLC, \$120,000, indoor air cleaner

Climate Change Pollutant Investigations: Closed 6 cases for \$933,000

Major cases: Closed four sulfur hexafluoride gas insulated switchgear (electricity generation) cases for \$772,200; closed two refrigerant management program cases for \$160,800

Portable Equipment Registration Program: *Issued over 12,000 new and renewed registrations*

Training Program: *Conducted 201 classroom and online classes in 25 subject areas for 6,800 students*

Visible Emission Evaluation Certification: *Conducted 62 classes, 44 day certifications, and 8 night certifications for 2,519 public and private industry participants*
