WORKSHOP TO DISCUSS UPDATES TO THE ZERO EMISSION BUS  
(ZBUS) REGULATIONS AND ZBUS TECHNOLOGY SUMMIT

The Air Resources Board (ARB or the Board) invites you to participate in a public workshop on September 17, 2013 in Diamond Bar, California, to discuss updates to the ZBus regulation and to explore the status of, and future developments to ZBus technology and related infrastructure.

At this workshop, ARB will establish the continued need for ZBus technology development. ZBus manufacturers and technology providers will discuss the current state of zero-emission bus technology and where they anticipate this technology will be in the near, and medium term future. In addition, transit agencies will share their experiences with procuring zero emission busses, operating within urban fleets, and maintenance challenges and opportunities. Staff plans to hold additional workshops following this workshop to explore regulatory options and to take comments on draft amendments prior to taking the regulatory package to the Board in May 2014.
