Ventura County Air Pollution Control District—Schedule of Assembly Bill 923 Motor Vehicle Fees

In accordance with an interagency agreement with the California Air Resources Board the Department of Finance, Office of State Audits and Evaluations, compiled a schedule of the Assembly Bill 923, Chapter 707, Statutes of 2004 (AB 923) motor vehicle fees for the period July 1, 2005 through March 31, 2012.

AB 923 increased the fee limit by \$2 that air districts could impose on motor vehicle registrations in order to provide funds for emission reduction programs. Revenue generated by the \$2 registration fee increase is for funding the Carl Moyer Program; new purchase, retrofit, repower, or add-on equipment for previously unregulated agricultural sources of air pollution; new school bus purchases pursuant to the Lower Emission School Bus Program; and an accelerated vehicle retirement or repair program.

To prepare the schedule, we compiled information from the Department of Motor Vehicles' AB 923 fee collection reports, the District's general ledger and supporting schedules of AB 923 receipts, expenditures, and interest earnings. We did not audit the accompanying schedule and do not provide any form of assurance on it. This letter will be placed on our website.
