SUBJECT: PUBLIC WORKSHOPS REGARDING AMENDMENTS TO THE OFF-ROAD REGULATION, THE TRUCK AND BUS REGULATION, AND THE TRACTOR-TRAILER GREENHOUSE GAS (GHG) REGULATION

The California Air Resources Board (Board) invites you to participate in the next series of public workshops to discuss proposed amendments to the Regulation for In-Use Off-Road Diesel Fueled Fleets (off-road regulation), the In-Use Heavy-Duty Diesel-Fueled Vehicles Regulation (truck and bus regulation), and the Heavy-Duty Vehicle Greenhouse Gas Emission Reduction Regulation (tractor-trailer GHG regulation).

### Background

On April 22, 2010, staff presented an update to the Board on the emissions inventories used to develop the off-road and the truck and bus regulations, as well as a summary of the impact of the recession on emissions from off-road vehicles, trucks, and buses. At that meeting, the Board asked staff to develop changes to the regulations that would reduce their economic impact on affected businesses during the ongoing economic recession, while continuing to protect public health, meet federal clean air deadlines, and move forward through uncertain economic times. The Board also directed staff to consider approaches to give credit to firms that have already complied with the performance requirements of the regulations.

In May of 2010, staff held a series of three workshops to discuss general proposals to amend the off-road regulation and truck and bus regulation and the emission inventories underlying both regulations.

This next series of workshops will provide additional detail on the proposed amendments to both regulations, as well as another update on the emission inventories. At each workshop, staff will also discuss proposed amendments to the tractor-trailer GHG regulation to allow additional flexibility in meeting the GHG reduction goals of the regulation and to clarify requirements.

Staff is tentatively scheduled to take proposed amendments to all three regulations to the Board for consideration in September 2010. A separate notice will be released for that hearing.

### Workshop Agenda

Following a brief introduction, staff will discuss proposed amendments to the tractor-trailer GHG regulation, followed by a discussion of proposed amendments to the truck and bus regulation, and after a lunch break, staff will discuss proposed amendments to the off-road regulation. At each session, staff will present proposed regulatory amendments as indicated below.

#### *Tractor-Trailer GHG Regulation*

Staff will present proposed amendments that would add flexibility to fleets' reporting requirements and address requirements for storage trailers and refrigerated van trailers. Additional amendments will also be proposed to clarify other requirements of the regulation.

### *Truck and Bus and Off-Road Regulations*

Staff will discuss staff's proposed amendments to the truck and bus and off-road regulations, along with a brief discussion of updates to the emission inventories for trucks and buses and off-road vehicles, as well as the results from staff's industry survey.

Staff presentations for each regulation will be followed by an opportunity for public comment and discussion.
