Subject: VESSEL SPEED REDUCTION FOR OCEAN-GOING VESSELS IN CALIFORNIA WATERS

The California Air Resources Board (ARB/Board) staff invites you to participate in our ocean-going vessel speed reduction public workshop. ARB is examining ocean-going vessel emissions at ports and along the California coast, as well as potential emissions and health benefits associated with reducing vessel speeds. This evaluation is a part of our continuing efforts to reduce diesel particulate matter, oxides of nitrogen, oxides of sulfur and carbon dioxide under the Diesel Risk Reduction Plan, Goods Movement Emission Reduction Plan and the Assembly Bill 32 – Global Warming Solutions Act of 2006. The purpose of this workshop is to provide a comprehensive update on ARB staff's technical assessment and to discuss concepts for a vessel speed reduction measure.
