## TITLE 17. CALIFORNIA AIR RESOURCES BOARD

### ADVANCE NOTICE OF INTENT TO FILE EMERGENCY REGULATIONS TRACTOR-TRAILER GREENHOUSE GAS REGULATION

This notice is sent in accordance with Government Code Section 11346.1(a) (2), which requires that State of California agencies give a five working day advance notice of intent to file emergency regulations with the Office of Administrative Law (OAL). The Air Resources Board (ARB or Board) intends to file an Emergency Rulemaking package with OAL that modifies the Tractor-Trailer Greenhouse Gas Regulation, Title 17, California Code of Regulations sections 95300 to 95312. As required by subdivisions (a)(2) and (b)(2) of Government Code Section 11346.1, this notice appends the following: (1) the specific language of the proposed regulation and (2) the Finding of Emergency, including specific facts demonstrating the need for immediate action, the authority and reference citations, the informative digest and policy statement overview, attached reports, and required determinations.

The ARB plans to file the Emergency Rulemaking package with OAL on February 29, 2012. Executive Order R-12-002, contains attachments A and B, which includes the Finding of Emergency, authority and reference for the proposed emergency regulatory amendments, informative digest, and disclosures and determinations regarding the proposed emergency rulemaking action are presented in the "Statement of Emergency" document, which is appended herein. If you would like to make comments on the Finding of Emergency or the proposed regulation, they must be submitted to **both** ARB and OAL within five calendar days of ARB's filing with OAL. Responding to comments at this point in the process is at ARB's discretion.
