Postponed Vapor Recovery Public Hearing Item

The vapor recovery public hearing item, which was heard and postponed on May 21, 1998 will continue at a public hearing starting August 27, 1998. The enclosed documents describe proposed changes to the procedures published for the May 21, 1998 public hearing. Please note that all hearing items relating to Onboard Refueling Vapor Recovery (ORVR) have been further postponed to the December 1998 public hearing. A workshop to discuss the ORVR procedure and the new Enhanced Vapor Recovery (EVR) proposal is scheduled for August 11 at 9:30 am (**NEW DATE AND TIME**) in the Board hearing room. The proposed revised TP-201.3 (pressure decay test) will also be continued to the December Board meeting.

The proposed changes to the remaining certification and test procedures are outlined in the enclosure; the full text and figures for the proposed changes follow the outline. In the enclosed documents, shading indicates text proposed to be added to the existing procedure while ~~strikeout~~ indicates text proposed to be deleted from the existing procedure. These are additional revisions to the proposed methods distributed April 3, 1998 (purple book).

We would encourage and appreciate your oral and/or written comments on the proposed amendments. As usual, your comments must be submitted to the Clerk of the Board or presented to the Board on the day of the public hearing to receive official consideration. As mentioned in the March 24, 1998 Public Hearing Notice, the Board encourages the public to bring to the attention of the staff, in advance of the public hearing, any suggestions for modification of the proposed regulatory action.
