Meeting on Air Quality Monitoring in Neighborhoods near Oil and Gas Facilities

California Air Resources Board (CARB) staff invites you to a public meeting to discuss air quality monitoring in neighborhoods located near oil and gas facilities.

CARB is interested in public input to develop an air study in California communities that are located near oil and gas operations. This source-specific study will incorporate monitoring throughout the state over time with months long stints in each community.

- Solicit input from community members, organizations, and interested parties
- Answer questions
