HSC 43019.1

New Off-Road, Aftermarket Parts, Components Fees

- Authority provided by SB 854 in 2018
- CARB may adopt a schedule of fees to cover all or a portion of the state board's reasonable costs associated with the certification, audit, and compliance as authorized pursuant to HSC 38560*, 43013 and 43018, and subdivision (h) of Section 27156 of the Vehicle Code.

*Fee authority applies to both criteria and GHG Executive Orders.

- Proposed application fees start January 1, 2022 (with OAL approval) for all applications. Model year based applications will initiate with the 2023 MY.
- Phase in for New, Partial-Carry Over and Low CA Production application fee. Zero emission and carry-over fees will not be discounted.





Low CA Production Manufacturer LSI (U-L) Exhaust

 A Low California Production Manufacturer produces a total of no more than 100 large spark-ignition engines annually for sale in California.

Application fee is 75% of category base fee





Low CA Production Manufacturer LSI (U-L) Evaporative

 A Low California Production Manufacturer produces a total of no more than 100 large spark-ignition engines, equipment or vehicles annually for sale in California.

Application fee is 75% of category base fee





Low CA Production Manufacturer of Off-Road Motorcycles, All-Terrain/Utility/Sport Vehicles, or Sandcars (U-M)

 A Low California Production Manufacturer produces no more than 300 Off-Road Motorcycles, All-Terrain/Utility/Sport Vehicles, or Sandcars vehicles annually for sale in California.

Application fee is 75% of category base fee





Low CA Production Manufacturer Watercraft (U-W) Exhaust

 A Low California Production Manufacturer produces a total of no more than 100 spark-ignition marine engines annually for sale in California.

Application fee is 75% of category base fee





Low CA Production Manufacturer Watercraft (U-W) Evaporative

 A Low California Production Manufacturer produces a total of no more than 75 sparkignition marine watercraft annually for sale in California.

Application fee is 75% of category base fee





Zero-Emission

- A mobile source technology that produces zero exhaust emissions of any criteria pollutant (or precursor pollutant) or greenhouse gas, excluding emissions from air conditioning systems, under any possible operational modes or conditions.
- Application fee is 25% of category base fee



Partial Carry Over

- A partial carryover application is identical to the previous model year's application except for:
 - Model year,
 - First letter of the Test Group/Engine/Vehicle/Evaporative family name,
 - Manufacturer contact information,
 - Projected sales data,





Partial Carry Over (Continued)

- A partial carryover application is identical to the previous model year's application except for:
 - Model names (may add models if the certification emission levels and worst case are not changed),
 - Part numbers (may add new parts if they are shown to be durable to full useful life and do not impact the certification emission levels), and
 - Equipment types.
- Application fee is 50% of category base fee





Carry Over

- A carryover application is identical to the previous model year's application except for the:
 - Model year,
 - Test Group/Engine/Vehicle/Evaporative family name (typically the first character),
 - Manufacturer contact information, and projected sales data.
- Application fee is 25% of category base fee

- Phase-in for New application fee. Add No Change Renewal, Administrative or Model Change fees will not be discounted.





No Change Renewal Portable Containers - G series

- Renewing an EO (Title 13 section 2467.2) for portable fuel containers or their components:
 - No changes have been made that affect portable fuel container systems' or their components' evaporative emissions.
 - A Holder must submit a signed declaration stating that no changes have been made that could affect the portable fuel container systems' or their components' evaporative emissions.





No Change Renewal Portable Containers - G series (Continued)

- Renewing an EO (Title 13 section 2467.2) for portable fuel containers or their components, continued:
 - The signed declaration shall also state that the certification test data originally submitted to CARB still represents the fuel container system with the highest diurnal emission rate relative to the applicable diurnal emission standard.
- Application fees is 25% of category base fee





No Change Renewal SORE - Q series

- Renewing an EO (Title 13 section 2767.1) for a fuel line, fuel tank or carbon canister:
 - No changes that affect the fuel line's or fuel tank's evaporative emissions or carbon canister's butane working capacity.
 - A Holder must submit a signed declaration stating that no changes have been made that could affect the fuel line's or fuel tank's evaporative emissions, or the butane working capacity of the carbon canister.





No Change Renewal SORE - Q series (Continued)

- Renewing an EO (Title 13 section 2767.1) for a fuel line, fuel tank, or carbon canister, continued:
 - The signed declaration shall also state that the certification test data originally submitted to CARB still represent the highest permeation rate fuel line or fuel tank, or the butane working capacity of the carbon canister, as applicable.

• Application fee is 25% of category base fee





Administrative/Model Change Portable Containers (G),SORE (Q)

Marine(RM) and OHRV (RV) series

- Administrative changes to an existing EO, with no changes to components that affect emissions
 - company name, component labeling, adding or removing component models
- EO holder submits signed statement from authorized representative declaring:
 - No changes have been made that could affect the component's evaporative emissions.
 - The certification test data originally submitted to CARB still represents the component's emissions relative to the applicable standard.





Administrative/Model Change


Portable Containers (G), SORE(Q), Marine(RM) & OHRV(RV)

- Administrative changes to an existing EO, with no changes to components that affect emissions
 - company name, component labeling, adding or removing component models
- EO holder submits signed statement from authorized representative declaring:
 - No changes have been made that could affect the component's evaporative emissions.
 - The certification test data originally submitted to CARB still represents the component's emissions relative to the applicable standard.
- Application fee is 25% of category base fee 22
